Column I: Time Taken from HC/ Tribunal to SC Reference Order

Definition: Time taken (in number of days) from the final judgement of the High Court/ Tribunal till the Supreme Court Division Bench order referring case to a Constitution Bench.

Column J: Date of SC Reference Order

Definition: Date on which a Division Bench of the Supreme Court referred the case to the Court Registry to be listed before a Constitution Bench.

Column K: Time Taken from Reference Order to Constitution Bench

Definition: Time taken (in number of days) from the date of Reference Order till the final judgement by the Constitution Bench.

Column L: Date Decided by Constitution Bench

Definition: Date on which the Constitution Bench passed the final judgement.

Column M: Total Time taken from HC/ Tribunal till Final Judgement

Definition: Time taken (in number of days) from the date of judgement by the concerned High Court/ Tribunal till final judgement of the Constitution Bench.

Definition: Whether the judgement of the High Court/ Tribunal was confirmed or reversed on appeal by the Constitution Bench.

Definition: Whether the judgement of the Constitution Bench continues to be good law, i.e., not overruled by a larger bench of the Supreme Court. Last updated on 16th August 2021. Sourced from Manupatra's Case Analytics Feature.

Column P: Times Cited by Supreme Court

Definition: Seniority of the judge (in days) as on date of judgement. Calculated as number of days between the date of appointment as Supreme Court judge and date of the judgement.

Column AU: Whether Unanimous Verdict

Definition: Whether the verdict in the present matter was unanimous.

Format: Yes/ No
